When you arrive...

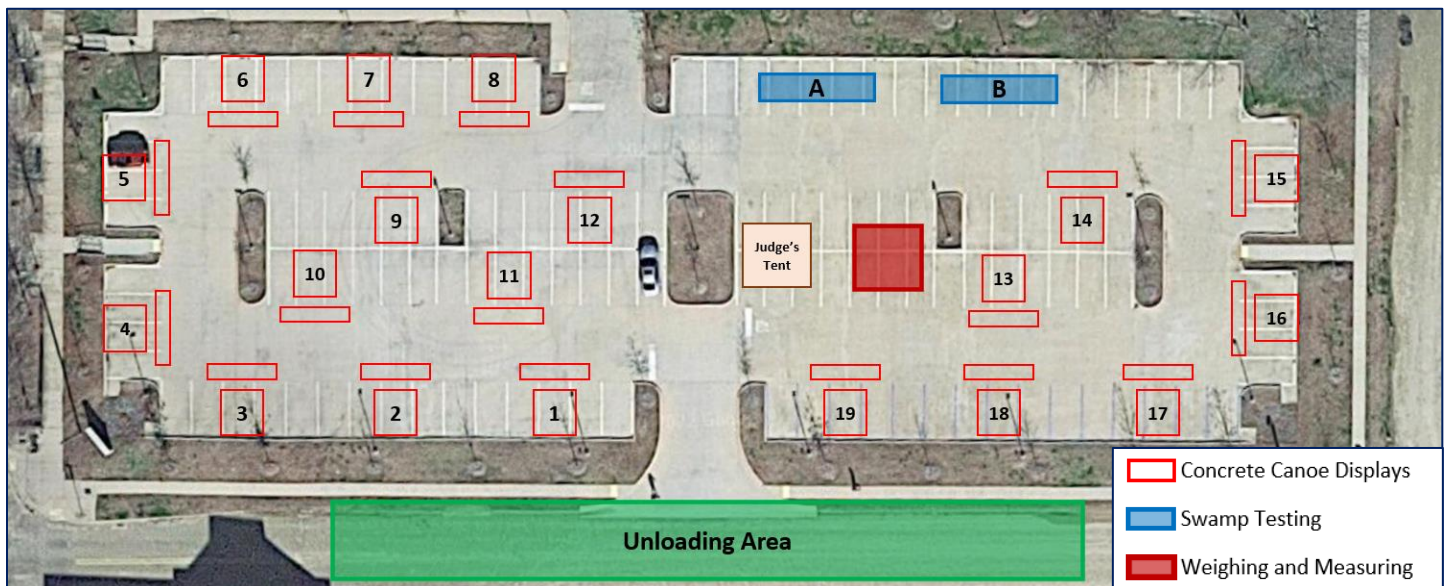
When you arrive on campus there will be signs to guide you to the right location per each day's schedule. Registration/Check-in will be in the Integrated Engineering and Science Building (IESB) (large brick and glass building with a fountain) when you walk in the front doors. You will register with us and our conference services staff, be directed to your housing facility, greeted by our volunteers, and get settled into your rooms. The Concrete Canoe Captains meeting is at 8pm in IESB 318. The UESI Surveying Captains meeting is at 8pm in University Hall 134, the auditorium.

Dress for hot weather, and potentially getting into the water. Besides the Banquet (Business or Business Casual Attire) everything will be up to you to wear something comfortable! Bring your school spirit to the Crawfish Boil Block Party by wearing your university colors/attire!

Please park all trucks and trailers in the gravel parking lot located to the east of the Integrated Engineering and Science Building, so that we do not congest the parking for housing or general lots.

Unloading for Concrete Canoe Displays

There will be a designated loading/unloading zone for getting your canoes into the Display Area and a specific time slot for your team to arrive. We suggest unloading everything as quickly as possible and then moving your truck to the parking area so that teams behind you may enter the unloading zone. The loading/unloading schedule will match the swamping/weigh-in order.



Concrete Canoe Weigh-in/Swamping

Teams will be swamping canoes in one of two locations: Swamp Tank A and Swamp Tank B. You will be directed to which swamp tank you will be using based on the unloading schedule. Please feel free to get in the water to guide the canoe in the tank. There will be buckets available and help if you need it. We are going to try and make this process as efficient as possible so that we can get you all finished and back to relaxing with your displays.

Weigh-ins will be done before swamping on automotive scales stationed near the swamp area. There will be foam on the scales so your canoe is protected but it will require you to lift the canoe onto the scales and then back off, from the ground.

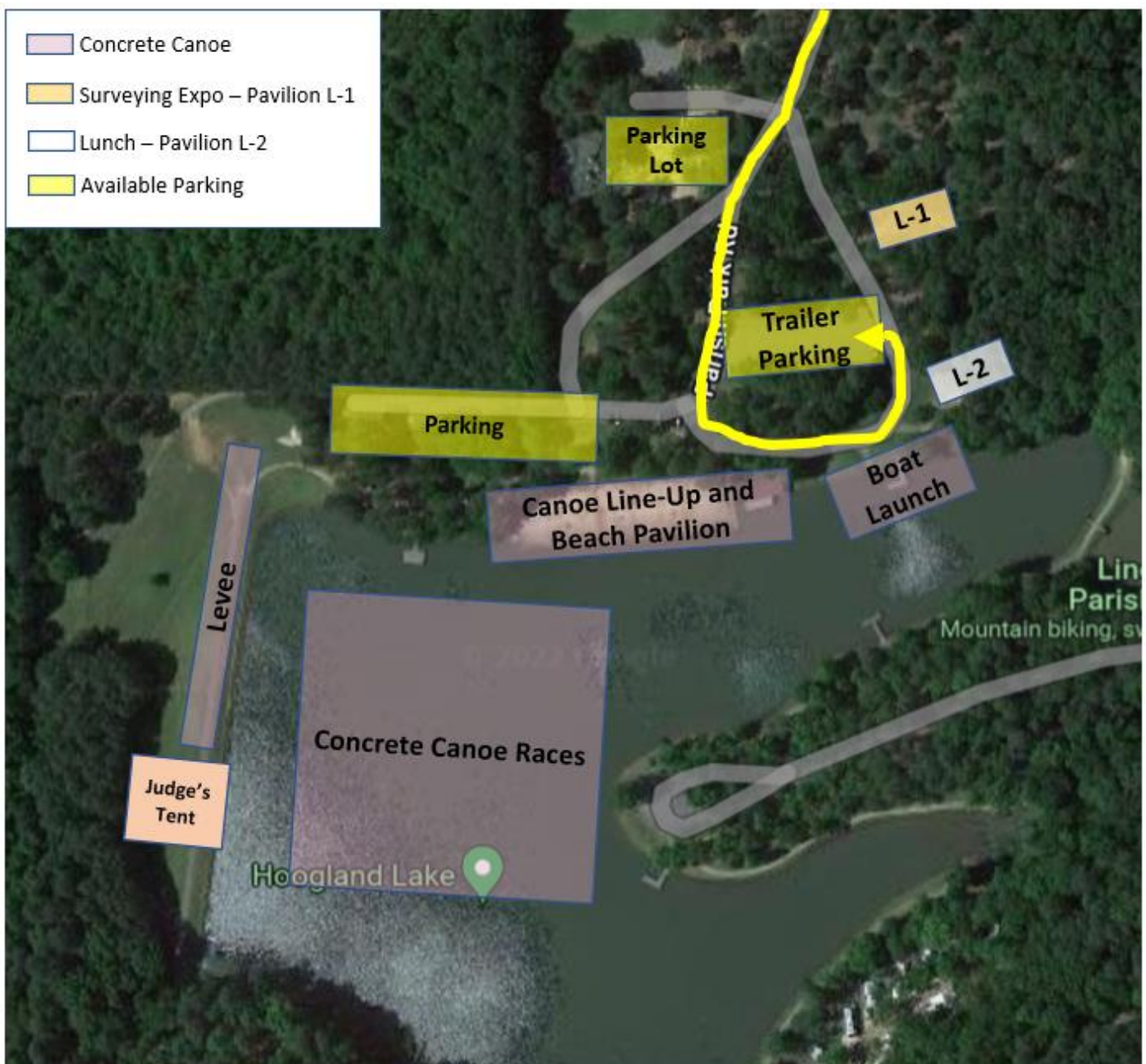

Concrete Canoe Race Day

Race day unloading will begin at 7:00 AM, but we recommend you get there slightly earlier to help keep the process going. When you get to Lincoln Parish Park, you will give the front guard stand the Canoe tab off your wristband and follow directions towards the beach. Pull around to the boat launch, get your boat in the water, then park in the trailer parking area. You can then bring your canoe to the beach. Please set up tents on the beach, however, feel free to head to the levee for a closer view of the races. No spectator tents will be allowed on the levee. Restrooms are located at the Beach Pavilion. Shipping and Receiving

Shipping the canoe will be much like anyone else shipping a package to us. You will address it to us in a specific way (see below) and make sure your carrier has some instructions (we would prefer if it could be delivered with a flatbed or truck with a lift-gate, no package over 2000lbs), and then you will work with me to pick it up when you get here. We will handle it on arrival and take it to the storage location. We will inspect for damage and let teams know if anything appears wrong when we receive.

Once you get here, you can come to unpack it and sign for it... after that, it's mostly on you to get it to where it needs to go. Some teams rent a truck locally and ship their canoes on a movable platform. We will of course try and help as much as possible but will not be able to help everyone at the same time.

If someone from your university wants to arrive a few days before and unpack the boat (we can work out early arrivals) so that it's mostly ready when the rest of the team arrives, we can talk about that too.

At the conclusion of the event, we can assist in shipping your canoes back BUT **the majority of the responsibility of packing, preparing, and coordinating shipment rests with the teams.** Please contact [Katya](#) if you would be interested in disposing of your canoe.

Housing and Dining

Teams staying on campus will be assigned to single or double rooms and, depending on the room style, will have access to kitchens and refrigerators. Alcohol and Tobacco

Parking on Campus

These parking lots will have signs signaling that they are available for parking. If you do happen to get ticketed, KEEP YOUR TICKET and turn it into us when you check out. Please be aware and careful when driving throughout Ruston, there are many one-way streets.

Weather and Nature

Early summer in Louisiana typically tends to not have much rain. However, the heat index during the day can get up to 100 °F, while the nights tend to be cooler. ATTENDEE WAIVERS OF LIABILITY

If the waiver isn't received at check-in, you will not get your dorm room keys and may be ineligible to compete as a team member in your competition.

COVID POLICY

As part of the entry requirements to 2022 ASCE Concrete Canoe Competition⁺, all attendees must provide proof of vaccination, or a negative COVID-19 PCR test (within 72 hours) through our provider in order to enter. If you were vaccinated outside of the United States, or if you do not wish to use the CLEAR Health Pass app, please verify your vaccination status by bringing your proof in person to the conference. Attendees who do not provide documentation as per this requirement will not be admitted.

To be considered fully vaccinated against COVID-19, you must have cleared the two-week waiting period after receiving your second dose of a two-dose vaccine (or two weeks after receiving a one-shot vaccine). This means your last vaccine had to have been administered no later than **Friday, May 20, 2022**.

ASCE will be partnering with the third-party vendor CLEAR to validate that each participant has filed the appropriate documentation to attend.
